

Full terms and conditions

1. Information on how to enter form part of the terms and conditions of entry. Entry into the competition is deemed acceptance of these terms and conditions.

2. The promoter is the Crookwell Potato Festival, a Committee of Upper Lachlan Shire Council, ABN 81 011 241 552, 36 Goulburn St, Crookwell NSW 2583, ph (02) 4832 1988.

3. Entry is open to school age children of all permanent residents of Australia. Employees and their immediate families of the Upper Lachlan Shire Council and the Upper Lachlan Tourist Association Committee are ineligible to enter the competition. Multiple entries are permitted.

Categories are: Preschool, Infants, Primary & High School

4. The competition commences at 9.00am (A E S T) on Monday 25th May 2020 and closes at 11.59pm (A E S T) on Monday 15th June 2020.

5. How to enter:

Step 1: Decorate your potato

Step 2 Take and edit your photo of your decorated potato

Step 3: Upload the photo to Instagram with the tags #upplachtourism and #crookwellpotatofestival2020 (Instagram privacy settings must be set to 'public' for us to retrieve your photo)

Step 4: Follow Crookwell Potato Festival and Upper Lachlan Tourism's Instagram accounts "@crookwell_potato_festival" and "@upplachtourism"

6. Only entries submitted via the Instagram application and which are appropriately hashtagged will be accepted. Photographs submitted must be original works.

7. Judging will take place on Tuesday 30th June 2020 at 3pm (A E S T) at the Crookwell Visitor Information Centre. Prizes will be awarded to parent or legal guardian of winning entrants.

9. The competition is a game of skill and chance plays no part in the selection of the winner. Submissions will be judged by a panel comprising representatives of the local Potato Industry, Crookwell CWA (Day) Branch, the Crookwell Potato Festival Committee and the Crookwell District Art Gallery.

10. Judges' decisions are final and no correspondence will be entered into. Prizes cannot be transferred. Non-cash prizes cannot be redeemed for cash.

11.
